

Nero Global Tracking's 20 More For Vegas Contest

Full Contest Rules and Regulations

Please Note: This contest is for residence of British Columbia only

1. **CONTEST SPONSOR:** This contest is sponsored by Nero Global Tracking.
2. **CONTEST PERIOD:** Starting approximately November 20, 2009 at 12:00:00 AM ET and ending February 1, 2010 at 11:59:59 PM ET (the "Contest Period"), at which time all qualified sales must be finalized and no further entries will be accepted.
3. **HOW TO ENTER:** During the Contest Period, simply purchase 20 new Nero Global GPS Beacons on a 3 year term or refer Nero Global new customers equating to a total of 20 new Nero Global GPS Beacons on a 3 year term, all purchased during the contest period, and you will qualify for the "Instant Win Prize". All sales must be finalized during the contest period to qualify. Your unique beacon identification number will be entered as your contest entry. Limit one entry per valid beacon identification number. All new Nero Global GPS Beacons purchased during the contest period, that are not used to qualify for the "Instant Win Prize" will earn entry into an "Enter to Win" draw.

6. Entrants (i) acknowledge compliance with these Official Rules including all eligibility requirements and, (ii) agree to be bound by the decisions of the Contest Judges, made in their sole discretion, which shall be final and binding in all

DISCLOSURES:
